Foundation FCU's Privacy Policy

Foundation FCU is committed to making available financial products and services that will enable its members to meet their financial needs and obtain their financial goals. Protecting personal information and using it in a manner consistent with member expectations is a high priority for everyone associated with Foundation FCU. Foundation FCU members also have a responsibility to safeguard their financial information.

To ensure that members can rely upon the quality of products and services we make available, Foundation FCU stands behind the following:

- Foundation FCU will collect only the personal information which is necessary to conduct its business. Foundation FCU will collect only that personal information which is necessary to provide competitive financial products and services and no more.
- Foundation FCU will protect personal information of its members. Foundation FCU will maintain strong controls to ensure that member information in our files and computers is protected. Where appropriate, we will use security-coding techniques to protect against unauthorized access to personal records, ensure accuracy and integrity of communications and transactions, and protect member confidentiality.
- Foundation FCU members will always have access to their information to ensure its accuracy. Foundation FCU members will always have the opportunity to review their information and make necessary changes to ensure that our records are complete and accurate.

- Foundation FCU will only share information when necessary to administer products and services we provide, when required to do so by the government, or when we partner with other businesses to offer a broader array of products and services.
- Foundation FCU will partner only with businesses that follow strict confidentiality requirements and offer products designed to enhance the economic well-being of its members. Under no circumstances will we authorize those firms to charge your account without your express consent, and we will not sell member information to telemarketing firms.
- Foundation FCU will provide all members a choice in how their information is used. Foundation FCU members may elect not to have their information shared with the credit union's business partners. We will tell our members how to exercise their choice, and we will take all reasonable steps to make sure their requests are followed. At least once a year, we will remind our members of their right to choose.
