

## **Corpus Christi City Employees Credit Union Scholarship Application**

Thank you for your interest in our scholarship program. Please read this page carefully. We will ask you to sign your application stating that you have read and understand this information. Please contact Corpus Christi City Employees Credit Union (CCCECU) if you have questions. Your application will not be considered unless Part 1, Part 2 and Part 3 of this application is completed in full. Your signature is required at the end of Part 1 of this application. Failure to follow all instructions will result in disqualification.

The Corpus Christi City Employees Credit Union Board of Directors will determine the number and dollar amount of scholarships that are to be awarded.

- Applicants and/or their parents or legal guardians must be a member in good standing at Corpus Christi City Employees Credit Union at least 30 days prior to submitting the application. Applicants must have a cumulative grade point average of at least 2.50 on a 4 point scale.
- Selection criteria may include but are not limited to: financial need, GPA, extra-curricular and community involvement, career plans and goals, and other scholarships awarded.
- CCCECU scholarships will be awarded to a recipient a maximum of two semesters per calendar year in the high school senior category and two semesters per calendar year in the post secondary category.
- Completed applications must be submitted to the Corpus Christi City Employees Credit Union office by the close of business on July 30<sup>th</sup> (for the fall semester) and December 15<sup>th</sup>, of the current year (for the spring semester) for full consideration of the selection committee.

## **Corpus Christi City Employees Credit Union Scholarship Application**

In an effort to reach the future generation of credit union members and to promote education to the youth in our community, Corpus Christi City Employees Credit Union awards scholarships to students. The monies will be deposited at the College or University where the student has applied and has been accepted for admission. The scholarship monies are to be applied toward tuition, fees, and books. Awards issued to applicants must be used during the school year of issue.

To be considered for the scholarship, a student must:

1. Be a high school graduate with a least a 2.5 GPA on a 4 point scale.
2. Establish a financial need.
3. Be currently enrolled or planning to enroll in an accredited community college, 4 year college or university, or a program leading toward a vocational or technical degree.
4. Be enrolled as a full time student (defined as a minimum of 12 college credit hours).
5. Submit a short essay, "Why Do I Wish to Continue My Education?" and "Why Should I Be Awarded this Scholarship?"
6. Submit a letter of recommendation from a teacher, school counselor or administrator.
7. Answer all questions.
8. Submit a current photograph.
9. The application and all requested documents must be postmarked no later than July 30, 2010.
