Take advantage of Members United Federal Credit Union's special **Skip-A-Payment** plan and skip a payment this holiday season. This is the season for family gatherings, gift giving and lots of extra expenses! MUFUCU can help with a special program that lets you skip a loan payment. If you have more than one loan, you can skip a payment for each loan for one month (excludes VISA Loans). You pick the month: November or December. A fee of **\$25.00** is charged for each loan you skip.

Print out, complete and sign the **Skip-A-Payment** request form below. Mail, fax or bring in the form to **Members United FCU at 3404 Monroe Street; LaPorte, IN 46350** by the 30th of the month prior to the month you wish to skip. Please indicate the account the fee should be deducted from (funds must be in your account at the time **Skip-A-Payment** request is received) or send in a check made out to Members United FCU for the fee. Remember each loan is \$25.00. **Delinquent loans, VISA loans, loans with repayment histories of less than 12 months and loans already under an extension agreement do not qualify for this offer. If recent data shows you have been delinquent on our loan(s) for any reason, the credit union reserves the right to deny your Skip-A-Payment application.** Your statement will show your current balance. If you have questions on how this **SKIP-A-PAYMENT** plan will affect your loan balance, please call the credit union at 219-362-3741 or 800-873-0850. *This offer ends November 30, 2008.*
