

# Borrowers' Certification and Authorization

## CERTIFICATION

The Undersigned certify the following:

## AUTHORIZATION TO RELEASE INFORMATION

To Whom It May Concern:

1. I/We have applied for a mortgage loan through Greater New Orleans FCU. As part of the application process, Greater New Orleans FCU and the mortgage guaranty insurer (if any), may verify information contained in my/our loan application and in other documents required in connection with the loan, either before the loan is closed or as part of its quality control program.
2. I/We authorize you to provide to Greater New Orleans FCU and to any investor to whom Greater New Orleans FCU may sell my mortgage, any and all information and documentation that they request. Such information includes, but is not limited to, employment history and income; bank, money market and similar account balances; credit history; and copies of income tax returns.
