

Loudoun Credit Union Scholarship

Thank you for your interest in Loudoun Credit Union's scholarship program. Loudoun Credit Union will be offering two (2) \$1,000 Scholarships for the class of 2012. Please read this page carefully. You will be asked to sign your application stating that you have read and understood this information. If you have questions, please contact Loudoun Credit Union at (703) 777-4744. **To be considered, your application must be signed.**

Eligibility Requirements

To be eligible for the 2012 scholarships, student applicants must:

- Be a member of Loudoun Credit Union, not just any credit union in Virginia;
- have joined Loudoun Credit Union by November 1, 2011;
- be the primary member of their own account, not just a joint owner on someone else's account. Applicant's account must be in good standing;
- entering college as a freshman who will be taking at least nine credit hours per semester at an accredited college or university. You may be in either an undergraduate program or an associate's degree program at a community college;
- entering a Technical School as a first year student.

Eligibility Policy

- Completed applications must be received at Loudoun Credit Union by the close of business on **March 10, 2012**.
- Please print or type application.
- All information given on the application must be true.
- Winners of the scholarship will be notified at the Credit Union's Annual Membership Meeting on March 23, 2012. If the student is not present, the student will then be notified by mail.
- Decisions of the Loudoun Credit Union Scholarship committee are final.

Criteria

Applicants are awarded based on the following criteria:

Academics	60%
School Activities	25%
Community Activities	15%

Application Instructions

- Verify that you, the applicant, have a share (savings) account with your name as the Primary Member.
- Read through all instructions before filling out any forms.
- Answer all questions. Do not use acronyms. For example: Use Future Farmers of America instead of FFA.
- Have someone else proof read your application.
- Include your transcripts. If your school is sending your transcripts, verify that they have been sent.
