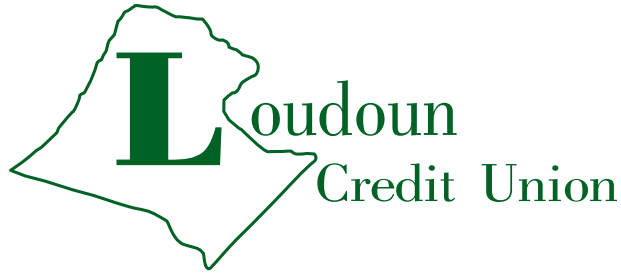

DIRECTIONS

From Eastern Loudoun County:

Rt. 7 West (Market Street) into downtown Leesburg to the point where it divides; bear left onto Loudoun Street and continue down the hill and turn left into the Market Station Shopping Center (the credit union is on the ground level, first door on the right).

From Western Loudoun County:

Rt. 7 East, take the first Leesburg Business exit, go through the first light and when the road divides, bear to your right onto Loudoun Street, continue through the second light at King Street and look for the Market Station Shopping Center on your right (the credit union is on the ground level, first door on the right).
