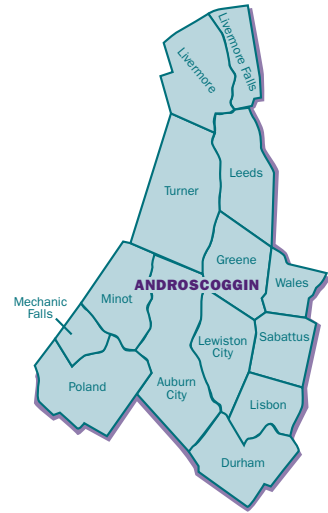

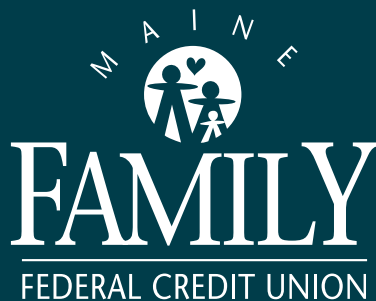

Make the switch to Maine Family Federal Credit Union

If the only reason you haven't opened a Maine Family Federal Credit Union checking account is because it's a hassle to close your old one, our hassle-free Switch Kit has been designed to make the switch simple and convenient. You may apply for a CU24sm VISA Check Card, transfer your direct deposit, automatic withdrawals like health club memberships, and close your checking account...all with this kit.



Here's how you do it ...

1. Open a Maine Family Federal Credit Union Checking Account

Apply for your Maine Family Federal Credit Union checking account. When you bring us the completed New Account Application, we'll process it and if accepted, give you a welcome packet with your account information and applicable disclosures. (You will need to open a savings account with us first if you don't already have one.)

2. Pocket a check card (debit card)

Complete the application for your CU24 VISA Check Card. When you bring us the application, we will process it, and if accepted, order you a card and present to you the Electronic Funds Transfer and Cardholder Agreement and Disclosures.

3. & 4. Here's all the forms you need to transfer your direct deposit and change your automatic withdrawals

Complete the Direct Deposit and Automatic Withdrawal forms. Mail the Direct Deposit form to the company or organization that is automatically depositing funds into your existing checking account. Also mail the Automatic Withdrawal form to all companies or organizations like health clubs that are taking withdrawals from your existing account.

Write your new account number on the forms. You may make additional copies of these forms if necessary.

5. Close down your old checking account

Once your direct deposit and/or automatic withdrawals start coming to your new Maine Family Federal Credit Union checking account, and you know all your checks have cleared your old checking account, mail the Closure Request to your previous institution and any remaining balance will be sent to your new checking account.
