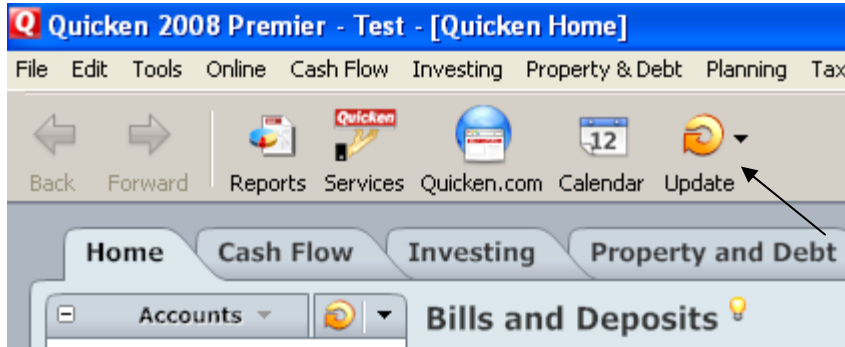
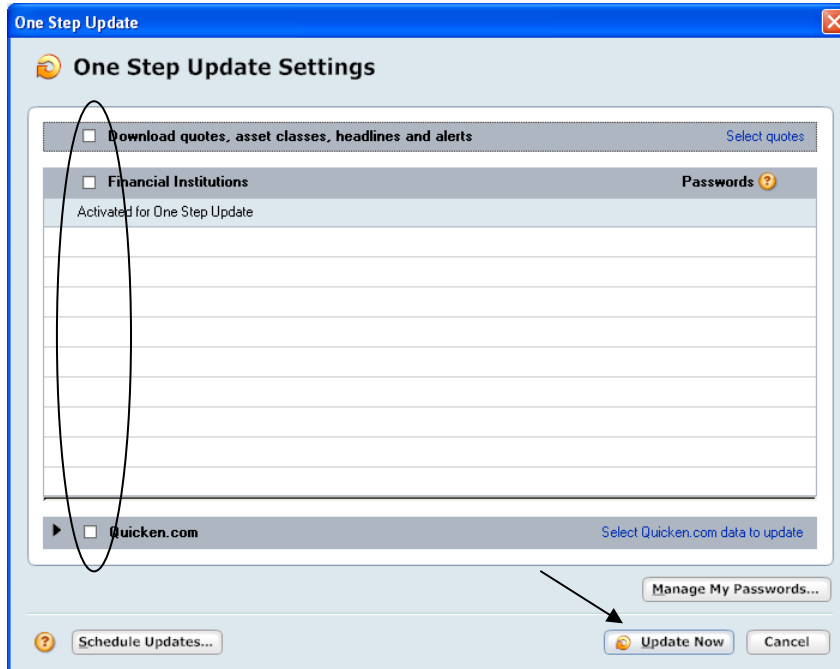


Quicken for Windows 2008 Direct Connect setup – New Users

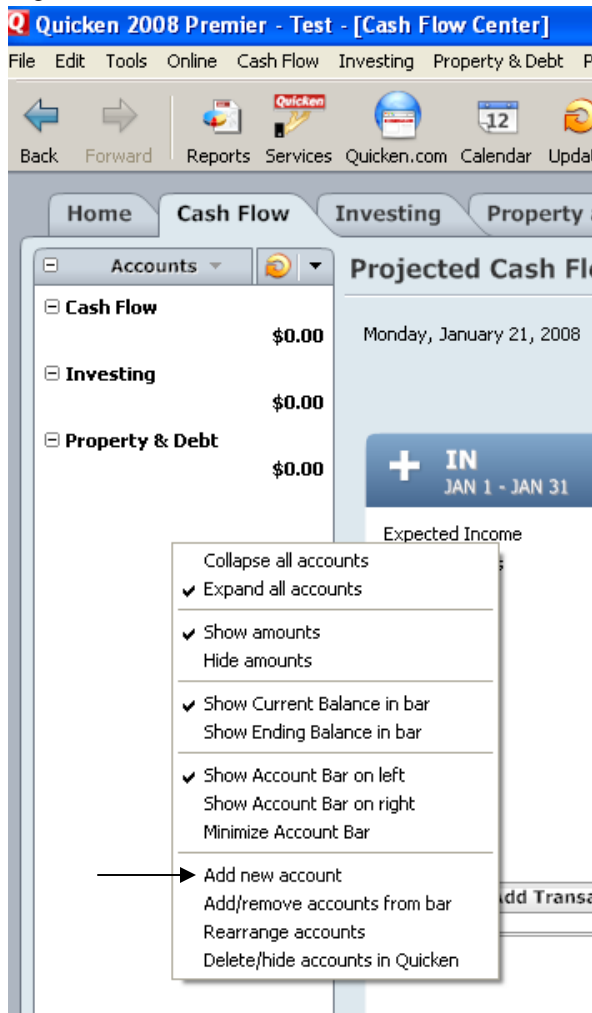
1. Launch the Quicken application
2. Click the **Update** icon on the toolbar to get the latest update from Quicken



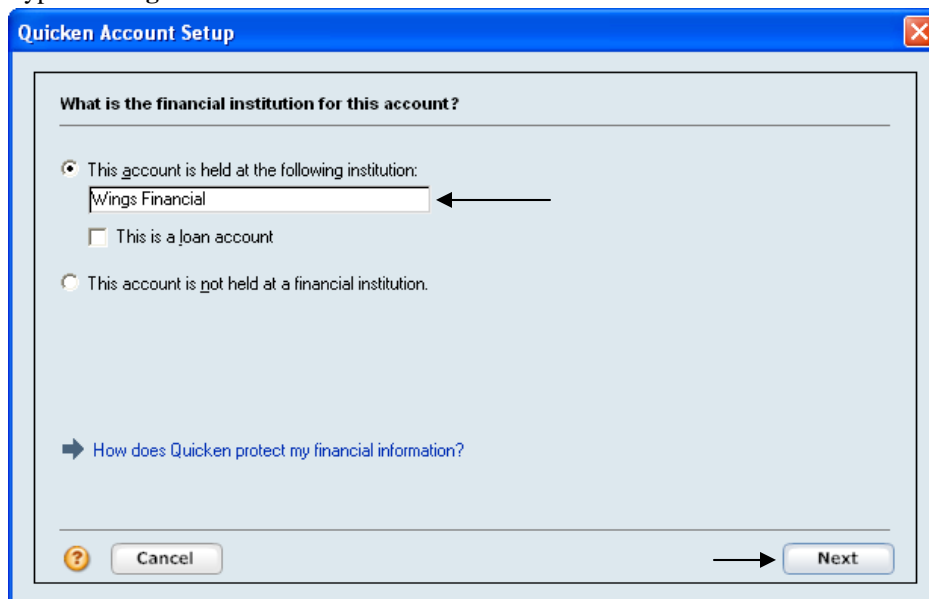
3. **Uncheck** all the checkbox in the One Step Update screen and click **Update Now**.
Note: If an update is available, apply it now. Once the update has been applied, Exit and restart Quicken



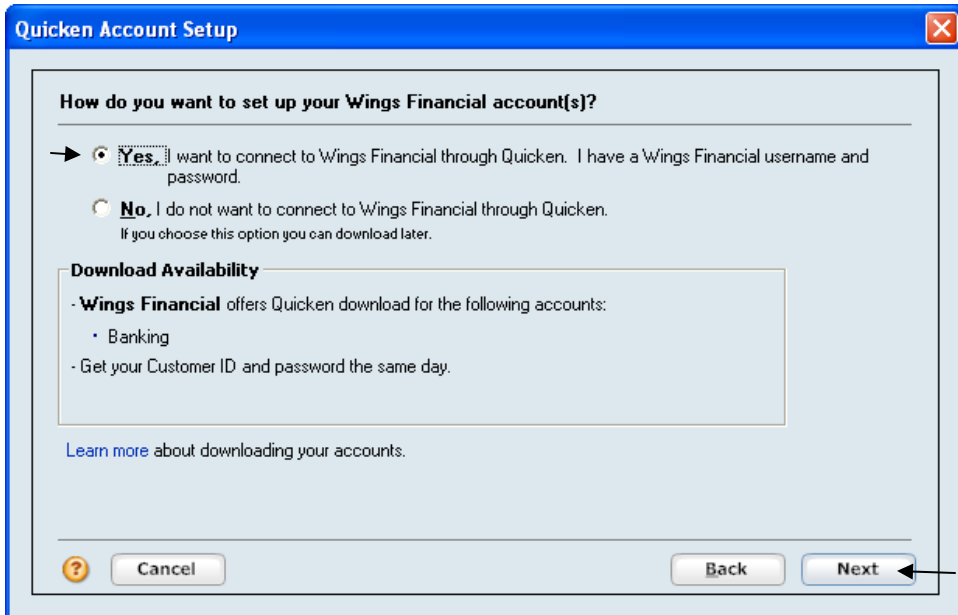
4. Right click in the Accounts section and select **Add new accounts**



5. Type in **Wings Financial** and click **Next**

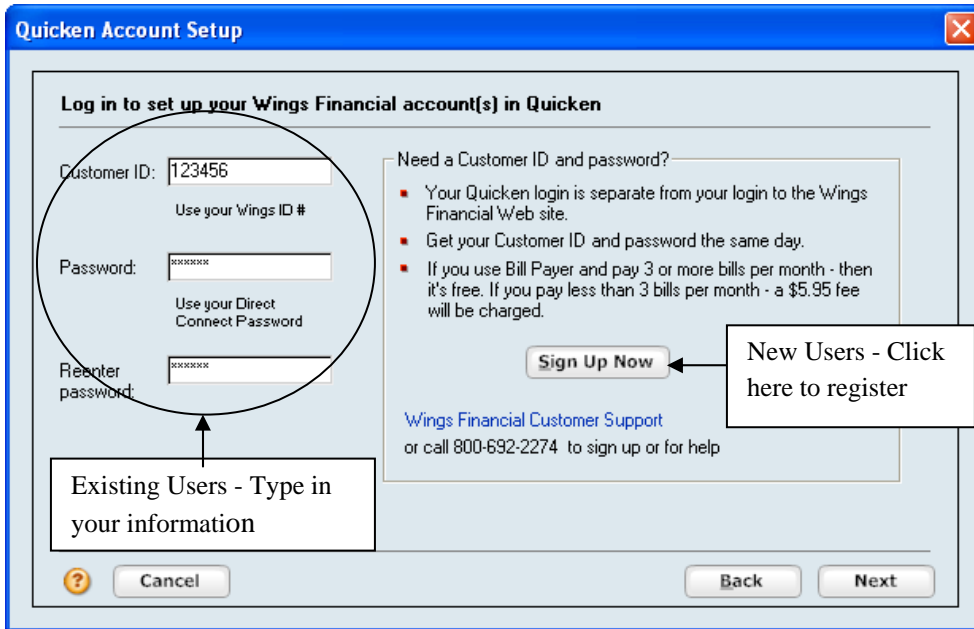


6. Select **YES** and click **Next**

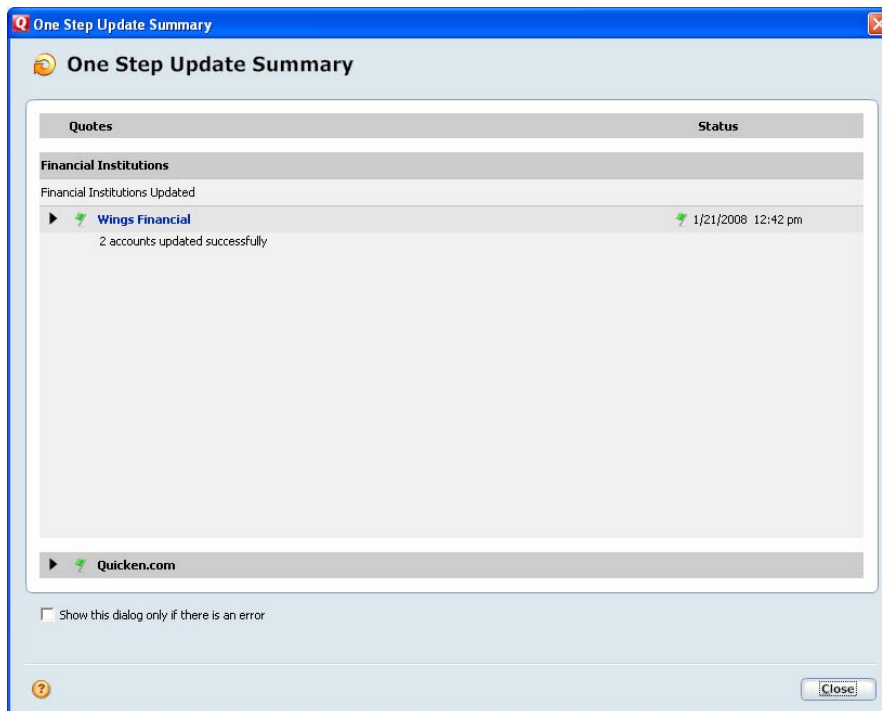
14. Quicken will list your Wings Financial accounts. Click **Next**
