



## **NOTICE of NOMINATIONS for BOARD of DIRECTORS**

There will be no nominations from the floor at the Annual Business Meeting.

### **Nominees for Board of Directors:**

**Edward Stucke** (Incumbent) - Mr. Stucke has been a member of the Credit Union since 1975. He has been a Board Member of Jefferson Parish Employees Federal Credit Union since 1980. He has held past positions on the Board as Secretary and Treasurer, and is currently Chairman of the Board. He has also served on the Investment Committee, Personnel Committee and other ad hoc committees such as Employee Salary Review and EDP Evaluation Committees.

Mr. Stucke has an M.B.A from Loyola University in New Orleans, along with undergraduate degrees in Accounting and Computer Science. He is presently employed by Jefferson Parish, as the Business Manager for the Jefferson Parish Libraries. Prior to this position he was Assistant Director of Jefferson Parish Community Action Programs and the Grant/Fiscal Manager for that department. Previous to employment with Jefferson Parish, he was an Administrative Director at East Jefferson General Hospital.

Mr. Stucke has served on the Boards of Pontchartrain State Bank, Archbishop Rummel High School Parent Board, Chapelle High School Parent Board, and was a member of Chapelle High School Finance Committee.

**Cynthia Austin** (Incumbent) – Mrs. Austin has been a member of the Credit Union since 1970. She has been a Board Member of Jefferson Parish Employees Federal Credit Union since 1984 and is currently serving as the Secretary of the Board. Mrs. Austin has also served on the Credit Union's Supervisory Committee and Personnel Committee.

Mrs. Austin is presently employed by the Jefferson Parish District Attorney's Office as the Federal Grants Manager. Mrs. Austin is retired from Jefferson Parish after serving for 34 years.

**Fran Hemenway** (Incumbent) – Mrs. Hemenway has been a member of the Credit Union since 1969. She has been a Board Member of Jefferson Parish Employees Federal Credit Union since 1985 and the Supervisory Committee Chairman of the Credit Union since 1999.

Mrs. Hemenway is retired from Jefferson Parish after serving 39 years. While employed with the Parish she held the following positions: Administrative Operations Coordinator assisting Director of Public Works, Administrative Aide assisting Director of Pump Stations, Administrative Assistant for Sewerage Department and Stenographer for Sewerage Department.
